OFFICIAL CONTEST RULES

The Science Centre Singapore x SISTIC Greek Giveaway Contest will hereafter be referred to as the “Contest”.

CONTEST PERIOD

1. The contest will be officially posted on **SISTIC page** <https://www.sistic.com.sg/events/cgreece1018>. It will commence on **8 Jan 2019** at **1000** hours (Singapore time) and end on **1 Feb 2019** at **2359** hours (Singapore time). Entries will only be accepted during this period.

2. Entries submitted after **1 Feb 2019** at **2359 hours** (Singapore time) will not be accepted.

ENTRIES' CRITERIA AND PARTICIPATION MECHANICS

3. These are the steps to participate:

a. Participants have to purchase tickets to The Inventions of Ancient Greece: Origins of Our Modern Technology exhibition tickets through SISTIC

b. Participants will need to fill in the survey monkey form: Link-

and answer the following question – “Tell us about your favourite memory at the Science Centre!”.

Science Centre Singapore has the right to disqualify and/or remove any entry that does not meet the above eligibility criteria.

c. Only participants who purchase the exhibition tickers through SISTIC will qualify to win in this Contest.

d. Science Centre Singapore reserves the right to disqualify incomplete submissions.

4. Employees of Science Centre Singapore are not eligible for participation in this Contest.
5. This Contest is open only to people residing in Singapore, aged 18 and above. Applicable phone, Internet, postal or any other charges may apply, and the participants shall be responsible for such costs and expenses.
6. Science Centre Singapore will select 3 winners that comply with the steps set out in paragraph 3 above, and the winners will be announced within 3 working days from contest end date.

15. In the event that any entrant is disqualified from the Contest, Science Centre Singapore at its sole discretion may decide whether a replacement entrant should be selected. In this event, any further entrant will be selected on the same criteria as the original entrant and will be subject to these Terms and Conditions.

RELEASES

18.
